2. The tenderers are advised to visit the site to assess the required work and familiarize themselves with the conditions. The tenderers may, accordingly, quote their rates for the above work. - 3. The tenderers shall submit the Earnest Money Deposit (EMD) of USD200.00 (US Dollar Two Hundred Only) in cash along with Tender documents. The EMD in respect of all unsuccessful tenderers will be returned on production of receipt after opening of tender.
- 4.The successful tenderer will have to commence the work within 3 days of issuing Work Order. After completion of the work, the successful tenderer will be required to ensure that the area is not spoil and the area is cleaned properly.
- 5. The payments will be released to contractors after satisfactory completion of the work.
- 6. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself /herself aware of the scope and specifications of work to be done and local conditions of work.
- 7. The Embassy does not bind itself to accepting the lowest tender nor give any reasons thereof.
- 8. EMD and successful bidder will to be converted into "Performance warranty" for a period of one year from the date of completion of work. The Performance warranty amount will be returned to contractor after one year. The contractor will have to replace the LED light, if it is damaged within one year due to quality.
- 9. Tenderers should quote the rate in **US Dollar** in neat, legible form and in figure as well as words. Alteration, erasures and indistinct figures should be avoided. Any corrections in the quoted rates by shall be made in ink only and shall be signed by the tender.
- 10. Tender must be submitted in a sealed cover super scribing "Installation of lamp posts with high watts LED lamps(100w) at Padonmar Road complex". Tender Documents will be available at Reception till 1100 hours on 23rd February, 2017. Tender Documents Intimation/tender quotation by fax/mail is not acceptable.
- 11. Tender for the above work may be submitted to "Head of Chancery, Embassy of India, 545-547, Merchant Street, Yangon. Last date for receipt of tender is 23rd February, 2017 till 12:00 hrs. Tenders will be opened on the same day at 15:00 hrs. in presence of bidders, who have submitted tenders and may wish to be present.
