### NOTICE INVITING TENDER

1. Sealed tender is invited from reputed contractors/firms for the external wall and corridor whitewashing work at Embassy Residence, India House, 35 Thantaman Road, Yangon. The scope of work is as follows:

1	Wall and ceiling painting with exterior paint of reputed brands in existing colour with minimum two or more coats and a coat of compatible primer to give an even shade in entire walls and corridors. The work also includes scrapping of surface (wall/ceiling) with sand paper, cleaning of all dirt/grease/loose pieces of scales removal of algal/plant outgrowth, preparation of surface including filling the pit holes, <b>applying putty wherever required</b> . The rates quoted shall include cost of all materials, labour, tools and any other expenses related with painting of walls and ceiling (wherever ceiling of Gypsum or concrete). 2	Painting of doors and windows. The work also includes scrapping of surface with sand paper, cleaning of all dirt/grease/loose pieces of scales, preparation of surface, applying putty wherever required. The rates quoted shall include cost of all materials, labour, tools and any other expenses related with painting of doors and windows.	External side of doors & windows


2. The tenderers are advised to visit the site to assess the required work and familiarize themselves with the conditions. The tenderers may, accordingly, quote their rates for the required work per sq. ft. area. The rates quoted should be inclusive of all taxes, if applicable. Tenders should also indicate the total area to be painted at Embassy Residence in the tender. The tenderers may call to Embassy (Tel: 391219 / 388412 / 243972) for any clarification regarding the above tender.

3. The tenderers shall submit the Earnest Money Deposit (EMD) of **USD500.00 (US Dollar Five Hundred Only)** in cash along with Tender documents. The EMD in respect of all unsuccessful tenderness will be returned on production of receipt after opening of tender.

4. The successful tenderer will have to carry out the whitewash/paint work within 3 days of issuing of Work Order. After carrying out the whitewash/paint of any area, the successful tenderer will be required to ensure that the floor/furniture etc. are not spoiled and the area is cleaned properly.



5. The payments will be released to contractors after satisfactory completion of the work.
6. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself / herself aware of the scope and specifications of work to be done and of the local conditions of the work.
7. The Embassy does not bind itself to accept the lowest or any tender or to give any reasons for not doing so.
8. Tenderers should quote the rate in **USD per sq. ft.** area in neat, legible and in figure as well as in words. Alternation, erasers and indistinct figures should be avoided. Any corrections in the quoted rates by shall be made in ink only and shall be signed by the tenderer.
9. Tender must be submitted in a sealed cover superscribing **"TENDER FOR WHITEWASH WORK AT EMBASSY RESIDENCE 2016"** on the tender documents issued by Embassy of India, Yangon. **Tender Documents will be available at Reception till 1700 hours on 10<sup>th</sup> November 2016.** Tender Documents Intimation of tender quotation by fax/mail is not acceptable.

Last date for receipt of tender is 11<sup>th</sup> November 2016 till 11:00 hrs.
