- 4. The payments will be released to contractors after satisfactory completion of the work.
- 5. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself /herself aware of the scope and specifications of work to be done and local conditions of work.
- 6. The Embassy does not bind itself to accepting the lowest tender nor give any reasons thereof.
- 7. Tenderers should quote the rate in **US Dollar** in neat, legible form and in figure as well as words. Alteration, erasures and indistinct figures should be avoided. Any corrections in the quoted rates by shall be made in ink only and shall be signed by the tender.
- 8. Tender must be submitted in a sealed cover super scribing "TENDER FOR RENOVATION OF KITCHEN AT EMBASSY RESIDENCE, YANGON 2018". Tender Documents will be available at Reception during office hours on weekday from 15.02.2018.
