3. The tenderers shall submit the Earnest Money Deposit (EMD) of **Kyats 500000/- (Kyats Five lakh Only)** in cash along with Tender documents. The EMD in respect of all unsuccessful tenderers will be returned on production of receipt after opening of tender.
4. The successful tenderer will have to commence the work within 3 days of issuing Work Order. After completion of the work, the successful tenderer will be required to ensure that the area is not spoil and the area is cleaned properly. All necessary safety measures during work will have to be undertaken by the contractor, with whom all liability, including third-party damage/loss would rest.
5. The payments will be released to contractors after satisfactory completion of the work.
6. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself /herself aware of the scope and specifications of work to be done and local conditions of work.
7. The Embassy does not bind itself to accepting the lowest tender nor give any reasons thereof.
8. An amount equivalent to 5% of total cost will be kept as "Performance warranty" for a period of one year from the date of completion of work. The contractor will have to repaint the wall, if it is damaged within one year due to quality of paint.
9. Tenderers should quote the rate in **Kyat** in neat, legible form and in figure as well as words. Alteration, erasures and indistinct figures should be avoided. Any corrections in the quoted rates by shall be made in ink only and shall be signed by the tender.
10.
