- 4. The successful tenderer will have to commence the work within 3 days of issuing Work Order. After completion of the work, the successful tenderer will be required to ensure that the area is not spoil and the area is cleaned properly. All necessary safety measures during work will have to be undertaken by the contractor, with whom all liability, including third-party damage/loss would rest.

- 5. The payments will be released to contractors after satisfactory completion of the work.
