Opening of Bid and Auctioning : 26.10.2022 (1600 hrs.)

3. Vendor(s) / interested persons may quote for any or all or for selected items as per his choice. The financial bid/quotations is to be filled and submitted in the format / proforma given in the bottom of this notice.

- 4. The interested vendor(s) / person may inspect the items on any working day from 19.10.2022 to 21.10.2022 between 10:30 a.m. to 1:00 p.m. at Embassy of India 545-547, Merchant Street, Yangon by contacting Embassy of India, Yangon (Tel No. 243972/388412/391219, Mobile 09254203243 (Ms. Lakhi).
- 5. Interested vendor(s) / persons should submit their quotes in a sealed cover in the prescribed proforma (given at the bottom of the notice) along with Bid security of Ks. 2 lakh (Kyats Two lakh only) for any / part / all items to the Head of Chancery, Embassy of India, Merchant Street, Yangon latest by 1600 hrs. on 25.10.2022. The cover should be supercribed 'BID FOR PURCHASE OF SCRAP ITEMS". The Bid Security can be paid by cash or bank transfer to Embassy's account. A receipt will be given. For Bank transfer, interested persons may contact Ms. Lakhi M 09254203243 for Embassy's Bank details. The Bid Security must be shown in Embassy's account by 25.10.2022.
- 6. The sealed tender will be opened (as well as auctioning) at 1500 hrs on 26.10.2022. The bidders may be present at the time of opening of bids/auction. The process is explained below:-
- 7. The highest offer of the items as submitted in sealed quotation shall be treated as lowest base price. Thereafter, there will be bidding/auctioning of the items and the item(s) (part or full) will be sold to the person / vendor who bids highest price during the bidding / auction. The minimum price to be quoted during hike for next bed will be Ks. 20,000/- (Kyats Twenty thousand only) or its multiple.

(Example: If the maximum quote for any items (say the Meat Safes) in sealed quotation is Ks. 5 lakh, it will be the base price for auction. Anyone (from among the persons / vendors who had submitted the quotations) willing to purchase the meat safes will have to quote for at least Ks. 5 lakh and 20 thousand or in multiple of Ks. 20 thousand over and above of Ks. 5 lakh etc.)

8. The successful bidder will have to remove the sold items within three working days after paying / depositing the bid price is Kyat with Embassy. The bid price is to be paid within three working days after the bidding / auction is over i.e. by 27<sup>th</sup> October, 2022 by cash or bank transfer to Embassy's account (if paid by bank transfer, it should reach Embassy's account by 27<sup>th</sup> October). If the bidder fails to pay the price within prescribed time i.e. 27<sup>th</sup>, the Bid Security of Kyat 2 lakh will be forfeited and the items will be offered to next highest bidder. If the 2<sup>nd</sup> bidder also fails to pay the Biding amount (within 2 working days after intimating him by phone / email) his Bid Security will be forfeited and the offer will be made to 3<sup>rd</sup> highest bidder and so on.

The forfeiture clause is applicable if the Bidder fails to keep his commitment for purchase for any / part / all items. For example, if a bidder is successful for purchase of five items and he subsequently changes his mind to purchase only three itmes, his Bid Security will be forfeited, however, he will be allowed to purchase the three items after paying the price and the other two items will be offered to next highest bidder.

- 9. Bid Security of unsuccessful bidders will be returned once the auction is over and the amount is deposited into Embassy account by successful bidder.
- 10. It is the responsibility of the successful bidder to remove all the sold items from Embassy with his own arrangement.
