4. The sealed tender will be opened at **3 p.m.** on **08.06.2020**. The bidders may be present at the time of opening of bids. The method will be quotation cum auction as explained in Para-5 below.
5. The highest offer of the vehicle as submitted in quotation shall be treated as lowest base price. There will be bidding/auction thereafter on the same day i.e. 8.6.2020 at 3.30 p.m.and whosoever will quote highest amount during the auction/bidding, the vehicle will be sold to him.
6. The sold vehicle will be removed by the successful bidder within two days of depositing the bid price in Embassy account or cash. Bid security \$ 500 is to be deposited in cash against receipt with Embassy along with quotation.
7. Bid Security of unsuccessful bidders will be returned once the car is sold and amounts is deposited into Embassy account by successful bidder.
