Scope of work is as under:

Providing and fixing of one additional layer of good quality concertina coil fencing outside iron grill below existing coils including Guard Room and around all tree trunks adjacent to boundary walls with punched tape concertina coil 18 inch dia and fixing the same at 4" gap with horizontal R.B.T. (Reinforced Barbed Tape) wire, iron angles, stud tied with G.I. staple sand and G.I.clips to retain horizontal, including necessary bolt, all complete.

Terms and conditions for the tender:

- 1. The contractors are requested to inspect the site of work and seek clarification on scope of work, if any from Head of Chancery or concerned officer before submission of tender document. As there may be certain technical improvements in the tender, the compulsory visit to site is advised.
- 2. The tenders **shall be open on 12.06.2018 at 1500 hr**. The successful bidder should comply with the prescribed specifications.
- 3. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself/herself aware of the scope and specification of work to be executed.
- 3. The contractor will have to follow the prescribed items of works in detail and to the design and specifications of work supplied regarding the installation of concertina coil.
- 4. Defect liability period shall be 6 months from the date of completion of work. Any defect arising in this period due to contractor's fault will be rectified by him at his own cost. Failure to do so shall lead to recovery from of security deposit.
- 5. A security deposit equal to 5% of the value of work will be deducted from Contractor's bills and will be returned after the completion of defect liability period, after ensuring successful performance of the system executed by the contractor.
- 6. The Contractor will remove all waste materials and clean the site at his own cost.
- 7. The tender shall be valid for 60 days from the date of submission of tender document.
